








RECOMMENDED STABILIZATION IN WORK PLAN






STABILIZATION FOOTPRINT (app. 2 miles)



2025 CAPITAL REVENUE FORECAST

♦ CASH ON HAND ON JANUARY 1 – \$1,993,205.52 (projected)
